



## DEPORTATION FROM GREECE

### NO ONE MAY BE DEPORTED DURING THE ASYLUM PROCEDURE

It is legally crystal clear: no human being may be deported during an ongoing asylum claim. Asylum seekers have proof of arrival and a registration card which legally prove that their stay in Greece is

permitted. The Greek Asylum Service must first clarify whether there is a need for protection. Only in case of a negative decision and an unsuccessful appeal is there a risk of deportation.

### LEGAL REPRESENTATION



RefuComm recommends that all asylum seekers on the Islands seek [legal assistance](#) as soon as possible or at least as soon as they receive a negative decision following the admissibility or eligibility interviews so that they can [appeal](#). Free legal aid should be provided by law.

The Greek Asylum Service, under pressure from the EU, is currently working on asylum procedures more quickly than before, so that the hearing can be carried out quickly and people can be returned to Turkey or to their own country.

Therefore, refugees should **prepare** themselves well for the asylum interview, in particular by drawing on the specific threats they see for themselves in Turkey or their country of origin and by clarifying places and dates of events. ## AFTER DEPORTATION

### Report your Deportation

1. **SAVE THE PHONE NUMBERS** of human rights organisations in Turkey who support refugees. A list of phone numbers is below. It is almost certain that your 'phone will be confiscated in detention wherever you are going, so keep a paper backup of the contact details hidden somewhere in your possessions, which are least likely to be taken away, or memorise the telephone numbers, or write numbers on your body.
2. **PUT A CALL TRACKING APP ON YOUR MOBILE PHONE, so that you know where you are.** There are at least 18 holding areas for deportees in Turkey, you may also be moved, it is likely you will not know where you are.
3. **PREPARE YOUR CONTACT INFORMATION:** You may be allowed access to a phone in detention to be able to call someone who can help you. **If you do get access to a phone in detention** the call could be as short as **3 minutes** and you may get one call a day so make sure you are ready to quickly give your exact name, nationality, languages spoken, location, date of deportation and date of birth when you contact support groups. Lawyers in Turkey can only access clients in detention if they have the exact registered names and proof that the detainee requested them, and even then it is often still very difficult for Turkish lawyers to get access to clients in detention.
4. **SHARE THIS INFORMATION WITH OTHER REFUGEES.**
